Child and Adult Care Food Program

Policy

Head Start requires the use of CACFP funds to cover the costs of meals for enrolled children. The Healthy Meals for Americans Act allows children who are enrolled in a federally funded Head Start program to be automatically eligible for free meal benefits in the CACFP.

INCA works collaboratively with all participating parents to identify and continually access, either directly or through referrals, services and resources that are responsive to each family's interests and goals, including emergency or crisis assistance in areas such as food.

Oklahoma CACFP Enrollment Form

Each year INCA must obtain documentation the Head Start/Early Head Start participants in order to confirm automatic eligibility for free meals.

- With parent/guardian signature, Area Supervisor/Family Engagement Coordinator complete a OKLAHOMA *CACFP Enrollment Form* for every enrolled child every year.
- Must include signature of Nutrition Manager authorized to provide the certification on behalf of INCA and the date.
- Nutrition Manager completes the CACFP Enrollment Information Form (roster) and updates monthly. Roster is distributed to bookkeeping and classrooms.
- Nutrition Manager keep a copy of the enrollment forms and roster on file and the classrooms keep an enrollment file and roster on site.
- Oklahoma CACFP Enrollment form must be updated annually on each child.

Oklahoma CACFP Meal Count

INCA follows all applicable CACFP guidelines, including meal counts, use of family-style dining implemented to the fullest extent possible, etc.

All Meal counts are taken at point of service.

Copies of meal count documents are kept on file.
